CHAPTER P-27.1 REG 2

The Professional Corporations Act

Title

1 These regulations may be cited as *The Professional Corporations Regulations*, 2002.

Interpretation

- 2 In these regulations:
 - (a) "Act" means The Professional Corporations Act;
 - (b) "real estate agent" means an individual who is registered pursuant to *The Real Estate Act* as:
 - (i) a broker;
 - (ii) a branch manager;
 - (iii) an associate broker; or
 - (iv) a salesperson.
