

EXTENDED ACCESS MEMBERSHIP (EAM) List

Saskatchewan College of Occupational Therapists (SCOT) extended access memberships are available to persons who are currently registered as an occupational therapist and are in good standing pursuant to the legislation of another jurisdiction in Canada. SCOT extended access members *must* maintain a valid licence or permit to practice in another Canadian jurisdiction while holding an extended access membership. If the EAM's licence expires in the jurisdiction in which they are registered in, this membership will be null and void.

An extended access membership entitles a member to provide virtual services to a person who is physically situated in Saskatchewan. Extended access members do **not** have a SCOT Practising licence and are not authorized to provide **in-person** services as an occupational therapist in Saskatchewan.
